
A Look Back on Our Parish Retreat

A Letter from Our Pastor

We Are Stewardship Parishes, Sharing Our God-Given Gifts



Dear Members of St. Joseph and Nativity of the Blessed Virgin Mary Parishes,

ur annual parish financial reports for St. Joseph and for Nativity of the Blessed Virgin Mary Parishes are included in this newsletter. Each year we are required to submit a report of the finances of our parishes to the Diocese of Cleveland as well as a report to you, the members of our parishes. So I ask you to take a good look at these reports of money that has come in and money that has been spent over the last fiscal year, which ran from July 1, 2023, through June 30, 2024. Also included are our budgets for the current fiscal year, ending June 30, 2025.

As stewardship parishes, we concentrate on sharing the God-given gifts of our time, our talent, and our treasure. I want to thank all of you who are so faithful to Sunday offertory each week and month through the use of your envelopes or online giving through direct debit or by credit card. You enable us to do as parishes what we do.

Sometimes people will say, "The Church should take care of that." Which translated means, "Other people should take care of that." They also say, "The Church has tons of money." A careful look at our financial reports quickly dispels that myth. We need to remember that we are the Church. Each of us is a member of the Body of Christ. And each of us is called to be a fully participating member of the Church.

As you look over these financial reports, I ask you to consider whether or

not the amount of your weekly or monthly offering might call for some adjusting. Sometimes we get used to a particular amount and it is good to review our personal circumstances and see if this gift of our treasure accurately reflects our life right now.

Household and personal expenses are going up each year, and so are those of our parishes. Whether talking about our parishes or our households, we cannot afford to pay our bills by steadily diminishing our savings. As participating members of our parish families, what is the Lord asking of you right now in terms of sharing a portion of the treasure that He has entrusted to you?

A number of people are making their Sunday offerings by online giving through myEoffering. I have been using online giving for my own regular contributions to the Sunday offertory to St. Joseph Parish and to Nativity Parish for a lot of years now. Online giving ensures that the Lord gets our first fruits each month, that the parish receives this contribution when people are out of town and it also is more convenient for those who use this method regularly to pay their bills.



Meet *Rachel MacDonald*, St. Joseph's New Director of Youth Activities

Fostering a Space for Teens to Be Themselves and Grow in Faith

S t. Joseph's new Director of Youth Activities, Rachel MacDonald, has hit the ground running and is eager to inject her passion into youth group activities, providing a healthy and fun place to learn and grow in faith and fellowship.

Rachel has a wealth of experience teaching and working

with young people — she has been a teacher since 2017 in the diocese, and she also teaches faith formation to fourth-graders. In the summer months, she works at a summer camp for middle schoolers. Since she does not formally teach high school students, she explains that she is grateful for the opportunity to direct the youth group outside of a classroom setting.

"All ages come with their own challenges, but they also have their own receptivity," Rachel says. "I really like working with the high school age group in this particular setting."

Raised with a rich faith background, Rachel has been involved in a long list of organizations and activities that supported her

own faith when she was growing up, including youth group in high school and the Newman Center in college.

"I have always loved my faith and sharing it with other kids," she says.

Rachel became involved with the youth group last year when she started volunteering her time to help out. Soon there was a need for a new director, and given her background, she took the position. She has been directing the youth since July. "I love the kids, and I love being a witness and role model," she says. "I feel like I can instill my own experience in them because ultimately it's about forming a personal relationship with Christ. I love it when they ask questions." Rachel believes her primary purpose is teaching and instilling

a sense of faith. She is planning activities that promote community service and fellowship among the youth.

"I want this to be a place where you can be yourself and grow in your faith," she says.

Since taking on this role, Rachel has initiated several new group activities and has other ideas she would like to put on the calendar. Over the summer the youth group had a game night, and as a part of the fall season, they made a trip to a corn maze. As for service opportunities, she is thinking about getting in touch with the elderly to possibly help them with yardwork for the service component.

"Fortunately, I have a great team of volunteers behind me who want to get the ball rolling," Rachel says.

Ultimately Rachel is excited to support teens in their spiritual journey, and she is open to hearing from them in order to foster a supportive atmosphere grounded in their Catholic faith.

he bishop then asks the following question: "Do you resolve to hold fast to the mystery of faith with a clear conscience, as the Apostle urges, to proclaim this faith in word and deed according to the Gospel and the Church's tradition?"

"I do."

This might be a function of deacons that you are most aware of. Deacons have a significant liturgical role that this promise seems to be alluding to, assisting the priest in the Liturgy of the Word through the proclamation of the Gospel and the role of preaching. Some of you have experienced the beginnings of this process through my reflections I've been giving for my preaching class. I hope they are a promising sign of the things to come! But this promise entails more than the context of Mass. As a cleric of the Church, deacons live out of the constant call to witnessing to the faith which they profess, one that goes back all the way to the beginnings of the Church. St. Stephen, the first martyr as we read in Acts, lives as a witness to this promise, professing his conscience and faith in Jesus Christ despite the overwhelming pressure and coercion to abandon the faith. This is the Church's tradition of professing the faith with a clear conscience, it can culminate in moments like St. Stephen's.

It feels daunting to know that this is the case. It's unlikely I find myself in the exact same circumstance. But how many moments will there be when I will be called into awkward conversations, tragic situations, or speak on the faith in places where it won't be received well?

I have this model to pray to and ask for his intercession in my own final months of preparation, but at the same time, there exists this clear example of how far such a promise entails going. This is part of the death that is symbolized when those to be ordained lay prostrate around the altar during the litany of the saints — the liturgy in which the models of the faith like St. Stephen will be called upon. It can be a death of my desires and comfort of where the faith is shared.

The proclamation of the faith is not restrained to Mass, it is a configurement to every moment of life, all the way to its end, natural or otherwise.
